TOURNAMENT REGULATIONS (to be retained)

1. Entry is open to all players registered with Leagues and Clubs affiliated to the Lincolnshire Table Tennis Association except players who have competed in any other County T.T.A. Closed Championship, or who have represented any other County Table Tennis Association during the current Season.
2. The league Singles event is open to any player registered in a Lincolnshire league, who has not represented any County and is not ranked in any ETTA ranking list.
3. ETTA Tournament Regulations apply to this tournament.
4. Completion and submission of this Entry Form signifies agreement by the entrant to the conditions of the competition.
5. All competitors will be required to umpire group matches and knockout matches at the discretion of the Referee.
6. All matches shall be the best of five games to eleven points. Play throughout will be on a knockout basis with the exception of preliminary rounds, which may, at the discretion of the Referee, be on a group basis. The final order in a group shall be determined as per ITTF Regulation 3.7.5. for Group competitions.
7. Competitors in Under 18 events must have been born on or after 31st December 1992
Competitors in Under 30 events must have been born on or after 31st December 1980
Competitors in Under 40 events must have been born after 31st December 1970.
Competitors in Veteran events must have been born on or before 1st January 1971.
8. Competitors must wear rubber-soled shoes and clothing, which complies with ETTA Tournament regulation 29.
9. Any member taking part in gambling, other than participation in any lottery or similar competition conducted by or with the permission of the organising committee, at a tournament approved by the ETTA, shall be liable to immediate disqualification from the Tournament and expulsion from the premises, either of which shall be reported to the ETTA.
10. All competitors must report to the control on arrival and must not leave the hall without first obtaining permission from the Referee. Players absent when called upon to play are liable to be scratched.
11. Should there be insufficient entries in any event the Referee reserves the right to cancel that event/merge such event and/or place the entrant in a similar event.
12. The referee's decision shall be final on points of law, and any question arising not provided for in these regulations, or in any dispute as to the interpretation thereof. Decisions on points of fact by an umpire or assistant umpire appointed by the Referee shall be final
